The Individual Professional Investor must inform Fortune in writing immediately if the Individual Professional Investor no longer falls into the categories of persons described in paragraph (j) of the definition of "professional investor" in Part 1 of Schedule 1 to the SFO and the Professional Investor Rules.

根據《證券及期貨(成交單據、戶口結單及收據)規則》,富強證券有限公司("富強")毋須向個人專業投資者提供成交單據、戶口結單或收據。儘管有此規定,富強或會繼續向閣下提供若干資料(儘管富強並無此義務),包括載有任何交易詳情的結單。Under the Securities and Futures (Contract Notes, Statements of Account and Receipts) Rules, Fortune (HK) Securities Limited ("Fortune") is not required to provide Individual Professional Investor with contract notes, statements of account or receipts.
